

Medical Therapy Services for Children Birth to Five Deliverable 5.1 Capacity Mapping Summary - May 2020

<u>Background and Context</u>: The *Pathways from Developmental Screening to Services* project is a community-level improvement effort focused on improving the receipt of services for young children identified at-risk for developmental, behavioral and social delays. One pathway for children identified at-risk for delays is medical therapy services, specifically occupational therapy (OT), physical therapy (PT), and speech therapy. In the Phase 1 activities, stakeholders noted the value of creating an asset map of current services and their capacity and applying an equity lens as it relates to access of those services for children who reside in different regions, whose parents may not speak English, and availability of culturally and responsible services.

<u>Medical Therapy Capacity Map Summary</u>: This summary report provides a summary as of May 2020 of the asset mapping that OPIP had conducted of medical and therapy services targeted for children birth to five in Central Oregon. As services, service providers, and capacity change, periodic updates to the summary table will be made as OPIP is made aware of changes in staffing, services, and capacity, we will ensure the summary is updated before the end of the project in May 2021.

Table 1.0 below provides an overview of the nine organizations identified February-May 2020 who provide occupational therapy (OT)/physical therapy (PT) and speech therapy specifically for young children. The information provided is based on interviews that OPIP was able to conduct March-May 2020 and will be updated by OPIP if updated information is provided by these organizations or new organizations are identified. As is noted in the summary below, OPIP is still awaiting information from St. Charles Rehabilitation regarding the number of providers and their capacity, and Bend Speech Express was not willing to conduct an interview or fill out the descriptive table provided as they noted they are "at capacity" and not receiving any additional referrals.

Part 3: Implications of Summary of Medical Therapy Services

Now that a majority of the service providers have provided site level detail, OPIP plans to provide the updated summary back to the providers and to highlight OPIP's summary about the implications of the current level and capacity of services. We also plan to facilitate a discussion at the next *Pathways from Screening to Services Stakeholder* meeting about the implications of this assessment and access to services. At this meeting, OPIP will share observations of barriers and opportunities as outlined below.

- Many providers are operating at or near capacity at this time, which may create a barrier to
 primary care providers being able to increase referrals to these services as they are guided to do
 via the Medical Decision Tree. This may negatively impact increases in follow-up rates.
- There is **inequitable access to services based on geographic location** as all clinic based services are located in Deschutes County only.
- One of four multidisciplinary providers interviewed offers home visiting services, and their home visiting services are available only within Deschutes County. Among Speech only providers, two of four providers offer home visiting, and each will consider home visiting outside Deschutes County given specific criteria and local need. Providers noted challenges associated with insurance coverage, time, and feasibility of supporting home visiting resources for children.
- **Culturally and linguistically appropriate services are limited** for diverse populations. Of the nine sites, only three sites reported ability provide services in Spanish. No physical therapy providers reported ability to provide services in Spanish.
