The Oregon Pediatric Improvement Partnership dedicated to building health and improving outcomes for children and youth in Oregon. A key area of focus within OPIP has been on improving health care services for young children focused on [social-emotional health](#). This has included a number of community-based improvement efforts that informed and guided OPIP's efforts to develop incentive metrics for Coordinated Care Organizations focused on social-emotional services, including the System-Level Social-Emotional Health metric and newly adopted [Young Children Receiving Social-Emotional Issue-Focused Intervention/Treatment Services](#) metric that starts in 2025.

**Purpose of these Webinars:** The overview webinar on February 20<sup>th</sup> and follow-up office hours are meant to ensure that Coordinated Care Organization understand the intent and purpose of the metric – including why parents and parent advocacy organization called for the metric, evidence-informed strategies that can be used to inform improvement efforts, and examples of key areas to focus that are informed by OPIP's community-based improvement efforts. Then, for people that attend or attest to listening to the webinar, OPIP will be offering an hour-long office hour session to answer questions that CCOs may have about metric and improvement strategies presented. OPIP plans to hold an additional webinar in June 2025 providing more detail on improvement strategies that can be used, with highlights from different regions.

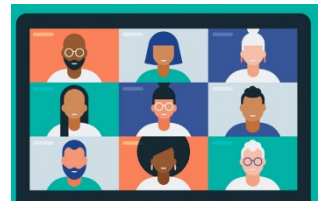
